## DOGBOY'S DOG RANCH MASTER BOARDING CONTRACT

I, \_\_\_\_\_\_ (first & last name), entrust DogBoy's Ranch (DogBoy's) to care for my dog(s) for his/her boarding stay and agree to all of the terms of this Master Boarding Contract ("Contract") listed below. I understand and agree that this Contract shall govern each time my dog(s) boards at DogBoy's, and that I shall sign a separate memorandum addressing the specific information regarding duration, grooming, and other information for each stay.

HEALTH & WELL BEING: I authorize DogBoy's to do whatever it deems necessary for the health and well being of my dog(s) and agree to pay for any and all expenses relating to same.

REQUIREMENTS: I acknowledge that my dog(s) is required to be spayed or neutered by the age of 6 months, unless otherwise notified. My dog(s) is also required to have a nylon, cloth or leather collar with both rabies and name tags while at DogBoy's, that DogBoy's will provide a collar and/or tags if necessary, and I agree to pay for the same. I also agree that all shot records shall be up to date, and if any are not, DogBoy's will arrange for the shots. I agree to pay for the shots and related expenses, including a trip fee to a local yet.

NIGHTLY BOARDING: I agree to pay for nightly boarding at DogBoy's posted rates and any auxiliary services or products requested by me such as transportation, grooming, etc.

PLAYGROUPS: I understand that DogBoy's will make every effort to include my dog(s) in playgroups with other compatible dogs, but that DogBoy's has the sole right to determine whether my dog(s) is included in playgroups. I also acknowledge that DogBoy's has provided me information about the "green", "orange" and "red" color coding system and I understand this information.

LIABILITY: I agree that DogBoy's is not responsible for any items I bring and leave at DogBoy's that are lost or destroyed. I also agree that DogBoy's is not liable for any injury inflicted upon another dog(s) by my dog(s), or any injury to my dog(s) including without limitation, injuries, illness, escape, or death, and that I am responsible for all costs and fees related to the same.

LATE/EARLY PICK-UP/DROP-OFF: I agree to pay a \$15 flat fee if I pick up or drop off my dog(s) within one hour before or after DoyBoy's posted operating hours or \$30 if more than one hour outside of posted operating hours.

NOTICE OF ADDITIONAL BOARDING TIME: I also agree to advise DogBoy's in the event I am unable to pick up my dog(s) on the scheduled pick-up date. If I do not advise DogBoy's in such an event, I agree to pay TWICE the posted nightly rate for each night my dog(s) stays beyond the scheduled pick-up date.

CANCELLATION POLICY: I understand that DogBoy's requires advance notice of cancellations as follows:

- 24 hours for a non-holiday reservation;
- 72 hours for a holiday reservation; and
- 7 days for the Thanksgiving and Christmas holidays.

I agree to pay \$50 or half the amount of the scheduled visit, whichever is less, if I do not cancel in accordance with this cancellation policy. I understand my reservation is not secure until I give a current CREDIT CARD number with expiration date to keep in my dog's file.

PHOTOGRAPHY: I give DogBoy's the right to use photographs of my dog(s) as often as desired. I waive right of approval and release DogBoy's from all claims which I may have on account of use of publication of any photographs.
